As City of Hope Orange County's chief physician, Dr. Kim is responsible for developing paradigms for translating research into clinical practice and introducing new therapies at City of Hope's new comprehensive cancer center, planned specialty cancer hospital and network of advanced cancer care in Orange County, Calif. He leads a team of acclaimed physician-scientists who are delivering world-renowned treatment, research and cures.

Prior to joining the City of Hope, Dr. Kim was chair of Solid Tumor Oncology and Investigational Therapeutics and medical director of the Clinical Trials Office at Levine Cancer Institute, Atrium Health, in Charlotte, North Carolina. He has held numerous leadership roles, such as tenured associate professor in the Department of

Thoracic/Head and Neck Medical Oncology at University of Texas MD Anderson Cancer Center. Dr. Kim completed his Master of Business Administration at University of North Carolina Kenan-Flagler Business School in 2020.
